moment for the future of health in Africa, and ensure the ongoing prosperity of AfHEA in its mission to support and enhance health policies across our continent.



#### Who are we?



# SELECTED ACTIVITIES AND ACHIEVEMENTS

### I. Bilingual Character and Volunteerism

AfHEA is one of the very few genuinely bilingual communities of people on the continent, although not perfectly so. Also, AfHEA's hallmark unique culture of tremendous trust which motivates members to volunteer for assignments time and again. That is priceless.

ii. Health Economics and Financing Technical Assistance Since its inception in 2009, AfHEA has provided technical assistance to various organizations and meetings. We highlight some of the more recent below: **1. Technical Support to UNAIDS on global strategic analytical pieces.** The Executive Director of AfHEA is a member of the Global Council on Inequality, AIDS and Pandemics set up by the UNAIDS and has provided support including developing guideline document for integrating HIV/AIDS into National Universal Health Coverage plans.

2. Technical Support to UNFPA on Investment Cases for Transformative Results. AfHEA since 2020 has been supporting UNFPA with technical support to support the development of Investment Cases for Transformative Results in some African Countries. This support has continued up to date with about five countries completing the development of their Investment Cases for Transformative Results (Botswana, Burundi, Mozambique, Namibia and South Sudan) while 2 others are currently ongoing, namely, the Democratic Republic of Congo (DRC) and Rwanda. The key UNFPA Transformative Results include ending preventable maternal deaths, ending unmet need for family planning and ending gender-based violence. These pieces of work are key for advocacy for increased investment in these areas.

**3. Technical contribution to a regional workshop on vaccine equity and manufacturing.** As part of efforts towards vaccine equity in Africa, which is a key focus area of AfHEA's ECOVA project, AfHEA participated in a high-level two-day NextGen Experts Workshop organized by the African Constituency Bureau (ACB) of the Global Fund on the theme, "African Position on Global Fund NextGen Market Shaping Strategy and Local Manufacturing". The workshop took place in Johannesburg, South Africa, from February 23 to 24, 2023 with participants from NEPAD, WHO, AFDB and UNAIDS among others. The discussions centered on local vaccine manufacturing in Africa and the four approaches of Global Fund's NextGen Market Shaping Strategy. The high-level meeting was aimed at developing a roadmap for advocacy and political engagement, drafting a position statement for Africa and its implications for NextGen Market Shaping, and providing inputs to guide the next market-shaping strategy's implementation among other objectives. #### 4. Technical Support to the World Health Organization Africa Region Office (WHO-AFRO) to Develop Health Budget Execution Case Studies in Selected African

**Countries.** AfHEA's strength lies on the diversity of expertise of its members across the African continent making it the best choice for strong technical support in the areas of health economics, financing, policy and in deed public health as a whole as it is often able to leverage on this strength to carry out high quality cross country analysis. Given this unique distinct value, AfHEA worked with WHO-AFRO to analyze health budget execution during the heat of the COVID-19 pandemic to inform public financial management best practices and reforms not only in these selected countries but as learning case studies across Africa. The purpose is to understand the trends of health budget execution, root causes of poor budget execution and the potential policies that can be introduced to mitigate these. This can then serve as learning examples for other countries to improve health budget execution. The case studies were done in Burkina Faso, Cameroon, Senegal and Uganda.

#### iii. Key Projects and Initiatives

As the go to organization especially on multiple country research and policy analysis activities, AfHEA continues to collaborate with donor organizations and development partners to implement impactful projects that ultimately contribute to improved health outcomes within the continent. Among these are:

The development of the investment cases have since been completed in Burundi and Mozambique while that of the Rwanda investment cases are still b e i n g d e v e I o p e d.

Equitable Access to the COVID-19 Vaccines in Africa (ECOVA) (Feb 2022- Mar 2025)	International Development Research Centre ( I D R C )	Following the observed inequities in COVID-19 vaccines distribution, access and uptake in Africa, which occurred as a result of numerous factors including unequal distribution of healthcare resources, limited availability resulting from limited production in Africa, heavy dependency on global supply chains as well as misinformation and disinformation, AfHEA collaborated with Africa CDC and the United Nations Economic Commission for Africa (UNECA) to implement the ECOVA project. This project is funded by IDRC. The project aims to glean lessons from the COVID-19 pandemic by generating evidence to support equitable access to vaccines in Africa especially by addressing the structural, economic, social, cultural, and political factors that impede vaccine equity and inform future strategies for pandemic preparedness. It focuses on deciphering the complex barriers to equitable vaccine access and provides a framework for strengthening health systems to be more responsive in times of global health crises. Special emphasis is placed on actionable insights and sustainable strategies that can be implemented by African governments and health stakeholders to foster greater equity in vaccine distribution. The project which started in 2022 and will end in March 2025 has a scope centered on equitable vaccine access in Botswana, Democratic Republic of Congo, (DRC), Ethiopia, Ghana, Kenya, Mozambique, Morocco, Nigeria and Zimbabwe.

Eeconomics of Adolescent Sexual and Reproductive Health (EcASaRH) Interventions in West Africa (Apr. 2019 – S e p t . 2023)	International Development Research Centre (IDRC)	The EcASaRH project, funded by the International Development and Research Centre (IDRC), kick-started in April 2019 and was completed in September 2023. The project has contributed to our understanding of how to identify 'promising' or 'priority' adolescent sexual and reproductive health (ASRH) interventions, with the West African Health Organization (WAHO) framework identified as a key tool for the identification. Under this project, the costs and funding gaps of the promising interventions and the strategies for mobilizing resources were also brought to light especially in the context of Ghana and Senegal. The importance of stakeholders' mapping and engagement in the process of such an exercise was emphasized. A number of the key outputs of the project have been published in diverse form to support evidence based ASRH policy making not only in Ghana and Senegal but also in West Africa as a whole. Among these are peered reviewed scientific publications and policy brief. #### iv. Capacity Strengthening

One of the overarching objectives of AfHEA is capacity strengthening in health economics, financing and policy in Africa. Therefore, capacity strengthening has been at the centre of AfHEA's activities over the years. We outline here some of the most important capacity strengthening activities of AfHEA since the 2022 conference.

#### 1.Virtual Capacity Strengthening Webinar on Scientific Communication for French-speaking Researchers

To support early career researchers especially in Francophone countries in Africa to improve their presentations quality for the 7<sup>th</sup> AfHEA conference, the Burkinabe network of health economists (CoBES) collaborated with AfHEA to organize a 2-day virtual training on the topic: Formation à la communication scientifique pour les jeunes chercheurs Francophones (scientific communication training for young French-speaking researchers). The workshop which took place from February 13-14, 2025 was aimed at equipping French-speaking early career researchers with adequate scientific communication skills including how to prepare power-point presentations and communicate effectively their research results to stakeholders. #### 2. AfHEA – Global Fund Health Financing Capacity Strengthening Workshop

With support from the Global Fund, AfHEA organized a capacity strengthening workshop in Abuja, Nigeria for researchers and policy makers from Ghana and Nigeria on the topic "Enhancing Data Collection and Evaluation for Sustainable Health Financing (ALM Tracker Tool)" from November 26-29, 2024. The purpose of this capacity building workshop is to strengthen the capacity of health and finance professionals in African Union (AU) member states specifically Ghana and Nigeria to assess and reform their health financing systems. By focusing on practical tools and strategies (the Africa Leadership Meeting (ALM) Tracker Tool), the workshop was aimed at equipping participants with the skills to collect, analyze, and use health financing data effectively, ensuring that public health funds are allocated and spent efficiently to improve health outcomes. The workshop trained approximately 34 participants on the above topic.

#### 3. Policy Brief, Manuscript Writing and Gender Considerations in Project Implementation Capacity Strengthening Workshop

As part of the ECOVA project, AfHEA organized a capacity strengthening workshop for about 9 consultants from 9 African countries working on the ECOVA project. The purpose of the workshop is to equip these consultants with adequate skills to effectively package and disseminate the ECOVA project results and findings from the research work in multiple ways to increase their chances of uptake into policy making in Africa. This writing capacity building workshop was convened in Accra, Ghana from April 29 – May 3, 2024. The workshop built the capacity of about 19 participants, especially the consultants working on the ECOVA project to package their findings in various formats such as policy briefs and manuscripts and in integrating gender dimensions into their research thereby enriching their work and increasing the chances uptake into public health policy in Africa. The workshop was also used as an avenue to quality assure the draft reports, policy briefs and manuscripts. There were about 19 participants drawn from eight African countries and the Middle East (Botswana, Democratic Republic of Congo, Ethiopia, Ghana, Kenya, Mozambique, Nigeria, Zimbabwe and Lebanon).

#### 4. Organization of a Virtual Capacity Strengthening Webinar on How to get Published

AfHEA in collaboration with Elsevier on October 11, 2023 organized a webinar titled Academic Journals – How They Operate, How to Get Published, and How to Get Involved. The webinar was intended to inspire researchers to publish their research papers in academic journals. The webinar was also in line with AfHEA's mentorship programme where senior researchers were selected to mentor early career researchers who presented papers at the IHEA congress to support the publication of their papers in a special issue with SSM Health Systems Journal. The webinar recorded over 150 participants from across different African countries as well as Europe and Asia. The main resource persons for the webinar were Prof. John Ataguba, Co-Editor-in-Chief, SSM – Health Systems and Canada Health Economics Chair, University of Manitoba, Canada and Matthew Smaldon, Executive Publisher, Elsevier, UK. The webinar provided overall insights into the publishing process shared participants the inspiration to be more confident as an author in the world of academic publishing, which is required to help them get their papers published more easily without giving up. The webinar equipped participants specifically with skills on:

- Typical article structure and language
- The process of writing building the article
- A clear idea of the steps needed to be taken before starting to write a paper.
- Skills to choose the right journal to submit a paper to
- Insights about author rights and responsibilities
- Understanding of sensitive areas such as publishing ethics, plagiarism and duplicate publishing.
- Clear perspectives on how peer review works and how to respond to feedback
- Useful resources to support researchers publish their papers

#### 5. Co-organization of a Capacity Strengthening Webinar on Extended Cost Effectiveness Analysis

On August 23, 2023, AfHEA collaborated with Africa CDC to organize a webinar titled Introduction to Extended Cost-Effectiveness Analysis and its Applicability for Public Health Decision Making in Africa. This webinar aligns with the capacity building pillar of AfHEA and attracted over 200 participants from different parts of Africa and some parts of Europe and Asia. Dr. Ahmed E Ouma, Deputy Director General of Africa CDC provided opening remarks on behalf of Africa CDC while Prof. John Ataguba shared some remarks on behalf of AfHEA. The key resource persons who supported the extended cost effectiveness analysis presentations at the webinar were: Prof. Stéphane Verguet. Associate Professor, at Harvard T.H. Chan School of Public Health, USA and Dr. Lelisa Fekadu Assebe at Africa CDC's Health Economics and Financing Programme Division.

During this capacity building webinar, a clear distinction was made between cost effectiveness analysis (CEA) and extended cost effectiveness analysis (ECEA). While CEA is a comparative analysis of alternative courses of action in terms of both their costs and consequences, ECEA is an extension of CEA that goes beyond costs and health outcomes to include additional dimensions like financial risk protection and equitable distribution of costs and effects in decision-making. ECEA evaluate health intervention/programs/policies in 4 dimensions while considering context-specific factors for policy impact assessment:

- Health gains deaths or DALYs averted.
- Financial risk protection benefits CHE or IHE averted.
- Distributional impact health and financial outcome per SES.
- Costs of policy (e.g., borne by government).

Participants were provided with specific ECEA analysis in different settings including Africa, Asia and the Americas. They were also taken through the rudiments and processes of conducting ECEA as well as the interpretation of results and findings of ECEA.

# 6. Organization of Pre-congress Capacity Training Workshop on Health Inequality and Equity in a Developing Country Context at the 2023 IHEA Congress in Cape Town, South Africa

AfHEA with support and collaboration from CHAI, Africa CDC and UNAIDS organized a pre-congress capacity building workshop on July 9, 2023 during the 15<sup>th</sup> IHEA congress in Cape Town, South Africa. The workshop was under the topic: Assessing and explaining health inequality and equity in a developing country context. Over 50 participants attended the workshop which trained participants on how to assess inequalities and inequities in the context of developing countries. # 7. Co-organization of Pre-congress Capacity Training Workshop on Health Technology Assessment (HTA) at the 2023 IHEA Congress in Cape Town, South Africa

This workshop was a collaborative initiative between AfHEA, Africa CDC, KEMRI Wellcome Trust and Clinton Health Access Initiative (CHAI). The workshop which took place on July 8, 2023 as one of the pre-congress activities of the 15<sup>th</sup> IHEA congress was titled "Introduction to Health Technology Assessment (HTA)". It was overly subscribed and attracted more than 70 participants including policy makers and researchers. The approach adopted for the workshop was a blend of technical analytics, policy and practice as facilitators were drawn from among researchers from KEMRI Wellcome Trust, Kenya and policymakers from Ghana's Ministry of Health HTA unit. The workshop provided foundational knowledge on HTA and its link and importance to UHC. Participants were made to appreciate the concept of HTA, why we need HTA, its benefits and application including practical examples of its application in different African countries such as Ghana and Kenya. # 8. Co-organization of Pre-congress Capacity Strengthening Workshop on Sustainable Health Financing Capacity Strengthening in Africa

AfHEA collaborated with Clinton Health Access Initiative (CHAI) and Africa CDC to organize a precongress workshop on the above topic. Prof. John Ataguba was one of the resource persons for this workshop which discussed sustainable financing mechanisms in Africa. The workshop which was held on July 9, 2023 took the form of panel discussion from different perspectives including policy, implementation, research and community perspectives as these groups were largely represented as per the panel composition. Discussants were Prof. John Ataguba (AfHEA), Dr. Regis Hitimana (Rwanda Social Security Board), Dr. Mieraf Taddesse Tolla, (Africa CDC), Kate Langwe, Director of Planning & Policy Development, MoH (Malawi), Vishal Brijlal (CHAI) and Sheetal Silal, Modelling Expert, University of Cape Town, (South Africa). Over 50 participants took part in the workshop and contributed to the discussion.

#### 9. Communicating Research to Policy Makers: Reflections from practitioners

On August 18, 2022, AfHEA in collaboration with Africa Health Observatory Policy held a virtual capacity strengthening webingr on the topic: Communicating Research to Policy Makers: Reflections from Practitioners. The target of this workshop was for researchers, especially early career researchers in health economics, financing and policy space in Africa. The workshop was organized to fill the observed gap between researchers and policy makers where it has been observed that while most research work is circulated and shared amonast the academic and scientific circles, little of it is shared in appropriate forms with other key stakeholders who need it most – the policy makers and end users. This workshop was therefore designed to enable researchers gain an appreciation for the knowledge and skills needed to effectively communicate research to policy makers. Researchers need an appreciation for how evidence is used to inform the policy making process. The nature of information that policy makers need is often different from research findings in papers, articles, and journals. Policy makers appreciate clear and concise information packaged in an easy-to-understand language. It is therefore important for researchers to learn the art and science of communicating research to policy makers so as to increase the usefulness of their research to policy makers. #### V. Other Initiatives and Activities

# 1. Formation and Operationalization of the Health Economics Curriculum Working Group (HEC-Group)

In collaboration with Africa CDC, AfHEA initiated the **Health Economics Curriculum Working Group** (HEC-Group) to redesign health economics and financing curriculum in Africa to better match the needs context of African countries. The 9 - member working group has representation from North, South, East and West Africa and is Co-chaired by AfHEA and Africa CDC. While preparatory work for the HEC-Group started in early 2024, with concept notes and preparatory virtual meetings, the maiden in-person meeting of the group took place in Accra, Ghana from June 20 - 21, 2024. This was followed by monthly virtual meetings until December when the second and final in-person meeting took place in Kigali, Rwanda from December 12-14, 2024. The objectives of the Health Economics Curriculum (HEC) are to:

- Develop core competencies of health economics training at various levels.
- Develop health economics modules/courses for masters, diploma, CPD etc. that can be offered using different delivery modes.
  - Propose various assessment modalities for the proposed curricula.

The HEC work is supported by IDRC, AFD, The World Bank and CHAI. The task of the HEC-Group is to development a better African context specific aligned HEC and disseminate this standardized HEC in Africa for possible uptake by institutions which could result in harmonization of health economics curriculum in Africa. The curriculum has since been developed and is scheduled to be launched and disseminated at the 7<sup>th</sup> AfHEA Scientific Conference in Kigali, Rwanda on March 10, 2025. #### 2. Organization of the All-Africa Side Event at the Sidelines of the 15<sup>th</sup> IHEA congress

The African Health Economics and Policy Association (AfHEA) organized an All-Africa Side Event at the sidelines of the 15<sup>th</sup> IHEA congress in Cape Town, South Africa in collaboration with Clinton Health Access Initiative (CHAI) and Africa CDC. The event took place on 10<sup>th</sup> July 2023 at the Gold Restaurant, Cape Town and was aimed to:

• Share experiences on recent and ongoing Health Economics (HE) capacity-strengthening activities and initiatives on the continent, and

• Identify and develop strategic capacity development activities and groups on teaching health economics (including curriculum design), policy engagements, research/early-career mentorship and strengthening, and other strategic health economics focal areas for Africa.

A total of 122 participants attended the informal event and discussion forum which served as a platform for key stakeholders to engage in meaningful conversations and share insights on HE in general, Health Technology Assessment (HTA) and other pertinent health economics issues. Overall, the All-Africa Event served as an invaluable platform where stakeholders exchanged experiences, ideas, and best practices and fostered strategic collaborations to strengthen health economics capacity in Africa. The event reignited conversation on health economics curriculum redesign, policy engagement, early-career mentorship, and cross-cutting strategic initiatives and laid the foundation for sustainable advancements in the field and ultimately improved health outcomes across the continent.

#### vi. Other Webinars and Stakeholders' Engagements

#### 1. The ECOVA Conference in Abuja, Nigeria

From November 20 – 22, 2024, AfHEA organized a conference under the theme Equitable Access to Vaccines in Africa: Lessons from the COVID-19 Pandemic for Future Public Health Emergency Preparedness and Response. The conference which was held in Abuja, Nigeria was aimed at mobilizing and sharing research findings around equitable access to vaccines in Africa including the country level studies of the ECOVA project. Research outputs mobilized from the ECOVA project as well as additional research around equitable access to vaccine within the African continent, selected through competitive call for abstracts formed the foundation for the conference. The conference brought together participants and stakeholders from North, South, East, West and Central Africa and attracted over 40 participants from over 13 African countries, majority of which attended physically with only a few participating virtually.

# 3. Organization of a Side Event at Africa CDC's 3rd International Conference on Public Health in Africa (CPHIA), Lusaka, Zambia

The side event which was organized on November 29, 2023 at the side-lines of the Africa CDC's 3<sup>rd</sup> CPHIA was one of the key activities of AfHEA's ECOVA project. The event was meant to share findings from a rapid assessment exercise conducted on governance, legal and economic policy frameworks to boost vaccine research and development (R&D) and production in Africa. The theme of the event was: Evaluating Policy, Legal and Governance Frameworks to Enhance African Research and Development Capacity: Feasibility of attaining the 60% Vaccine Manufacturing Goal in Africa.

The side event featured two key presentations that highlight opportunities for moving Africa on the path of the 60% vaccine manufacturing goal as well as a panel discussion. The two presentations included:

i. Progress towards achieving Africa's COVID-19 vaccination uptake and the 60% manufacturing target by 2040:

*ii.* Enhancing R&D for vaccine development in Africa through effective Policy frameworks: These were followed by a panel discussion with representation from key stakeholders in the vaccine landscape in Africa namely, Africa CDC and UNECA and AfHEA.

#### 4. High-Level EcASaRH Stakeholders' Engagement Workshop in Abidjan, Cote d'Ivoire

A major stakeholders' engagement forum on Adolescent, Sexual and Reproductive Health (ASRH) was held in Abidjan, Cote d'Ivoire as part of activities to climax AfHEA's EcASaRH project which was implemented between April 2019 and September 2023. This workshop which took place in Abidjan was organized by AfHEA in collaboration with the West African Health Organization (WAHO) from September 12-14, 2023. The workshop brought together over 30 Participants from 11 West African countries to discuss and disseminate findings from the EcASaRH project and to enhance the chances of uptake of these findings into national policies and strategies for addressing gaps in ASRH financing and programs in West Africa. #### 1. Co-organization of the Africa Health Economics and Financing Capacity Forum
